The World Affairs Council of Jacksonville, **a vital hub for civic and corporate leadership** in Northeast Florida, is a growing organization with more than 900 members. Our Board of Directors includes ambassadors, senior military officers, business & community leaders and government officials. Members value the opportunity to connect with other internationally minded citizens.

What We Do

Two signature speaker series on world affairs promote a better understanding of the world. Both the Global Issues Evenings at the University of North Florida and the Global Business Luncheons at The River Club offer diverse intellectual content, bringing light, not heat, to conversations about world affairs.

Educational programs offer students the opportunity to learn about current international issues beyond the textbook in real time context. The Council also supports teachers with resources to enhance their instruction on global topics.

BACKGROUND

History

The Council, formed in 1985 as the National Interest Forum, joined the World Affairs Councils of America in 1995. The World Affairs Councils of America is a nonprofit grassroots organization dedicated to educating and engaging Americans on global issues. With more than 90 councils across 40 states reaching more than half a million people a year, it is the largest of its kind in the U.S.

The Jacksonville Council has grown from a small organization sponsoring a modest speaker program, held in members' homes, to one reaching thousands of individuals every year through an acclaimed speaker series, educational programming, special events and an expanding network of young professionals.

In 2005, the Council received the World Affairs Councils of America President's Award for Outstanding Achievement, awarded annually to Councils that have shown extraordinary innovation, growth, outreach and impact.

In 2012, the University of North Florida presented the Council with the Presidential Medallion, in recognition of exemplary service and outstanding commitment to the University of North Florida and higher education.
